# **Food for Lane County**

**Carrie Copeland** provided the Board with an update on Food For Lane County and Trillium Produce Plus focusing on:

- Food For Lane County
  - Have 15 different programs.
  - o Funding: ~65% private, 31% government, 4% program income.
  - o In 2023 had 887,063 visits to FFLC distribution programs.
  - o Gratitude for Trillium, champions and supporters.
- Trillium Produce Plus (TPP)
  - O What is TPP and why is it important?
    - TCHP launched partnership with FFLC in 2018.
    - TCHP contribution increased in 2024 to account for the increase in food costs.
    - By the end of the current two-year cycle, TCHP will have invested \$520,000.
  - Priority partnerships
  - Food insecurity map
  - o Trilliums Role
    - 2018 Veggie Rx pilot program. 2024/2025 offering Vege Rx with our Start Smart for Babies program.
  - o TPP sites 2017-2024
  - Opportunities: what can we do, how can we address this?
    - Health care partnerships
    - FFLC food supply
    - Food systems work
    - Home delivery
