 - Selection process: include term rule for Chair/Vice Chair, minimum one year on Board.

- Membership Homeless and At Risk of Homelessness Tri-County Region. At risk of homelessness highest in ages 30-50 and 50-65.
 - o Rate of homelessness per 1000 & at-risk of homelessness per 100 members.
 - o At risk of homelessness by age group.

Melanie Westrick provided the Board with a utilization management update, highlights included:

- Early correlation between ED visits and PCP visits.
 - o ED visits per 1000 member months.
 - o % members with PCP visits.
 - o **Follow-up:** add graph for high utilizers of ED visits.
- Inpatient admits trending positively.
 - o IP visits per 1000 member months.
 - Average length of stay for IP.

Strategic Updates

Tom Bialozor provided the Board with a SUDs workgroup update, highlights included:

- Updates since last BOD meeting.
 - o Project Plan Completed to track deliverables and results for the project.
 - Update on data work.
 - Health Share data is close, not quite ready for merge.
 - Discussion: Potential next step to merge just the prevalence data (Dx by ZIP and Real-D). Board interested.
- Additional work in this Space.
 - o TCHP joined HB 4002 (2024) MOUD/ED workgroup.
 - Meeting with Multnomah County to assess possibilities for mobile MOUD Tx.
 - o **Follow-up:** Tom and Sean to connect on mobile MOUD services and further discuss how to maximize the effectiveness of them.
