## I. Welcome & Introductions – 12:00 to 12:15 PM

- *a.* Facilitator/Co-Chair, Tannya Devorak opened the meeting at 12:05 p.m.

  - CAC Member moved to approve the January CAC minutes as presented. Another CAC member seconded, and the motion passed.

## III. Updates & Announcements – 12:20 to 12:35 PM

- *a*. CAC outreach from Co-Chairs Caity Hatteras and Tannya Devorak
- *b.* CAC Resources & Opportunities Nena Hayes
- *c*. Health Equity Committee Update & Resources Tara DaVee
  - In February, Health Equity Committee members Tara DaVee and Ben Brock teamed up to share resources and opportunities from TransPonder.
  - Tara shared her experience participating in TransPonder's First Saturday coffee meet ups. One thing she learned is the importance of allowing individuals from the group to approach her in public spaces as a way to honor individual safety.

- Ben shared about who TransPonder is, what they do, and provided resources for interested community members from a staff perspective (shared in CAC Resources and Opportunities Spotlight).
- Ben shared that it seems like training would be important for the group's continued learning based on the questions coming up. Additional recommendations shared: seek training first when possible; consider the use of panels to hear from various perspectives; ask partners how the CAC/HEC can help.
- *d*. CAC and CCO leadership discussion
  - CAC Members would like to see more direct communication with CCO's.
  - It was discussed that CAC members want CCO's to have salary transparency because they don't want certain financial moves potentially take away money from community services.
  - It was known that OHA publishes information about CCOs spending online.

### IV. Discussion: CAC Training Exploration – 12:35 to 1:05 PM

- a. Questions for CAC:
  - Does the CAC want training?
  - What training does the CAC want?
    - CAC member mentioned they would like 1:1 internal dialogue with consumers instead of participating in trainings. CAC member wants to see implementation of a buddy system within the group where someone is a mentor and another

person, a mentee. They referenced and agreed with what another CAC member said earlier, which is to put everyone's skills to use.

- Another CAC member added that the CAC is a great team of people, and they strongly believe that everyone brings something to the table. For them, training is good because they want to feel more equipped. They personally struggle to defend themselves and speak up due to having trauma so in their eyes, everything they don't know is training.
- An attendee thinks there are a lot of layers in this work and that it is important to look at it through an individual perspective and as a collective because everything is intertwined.
- It was mentioned that we used to have trainings put on by OHA and there is a state level and CAC OHA office hours.

#### VI. Review: CAC Outreach Plan – 1:15 to 1:45 PM

- *a.* Kayla Watford (she, her, hers) with the help of Nena Hayes, led two breakout sessions where members could choose which to join
  - Breakout A will discuss the overall recruitment and outreach plan using an equity lens w/Kayla Watford.
  - Breakout B will be designing CAC materials w/Nena Hayes.
  - Kayla Watford shares <u>link</u> to the Jamboard for the next agenda iteming about CAC outreach and recruitment.
  - Kayla Watford shares the 2024-2026 Community Advisory Council (CAC) Outreach & Recruitment Plan pdf and wants CAC to look at the draft outreach plan together and initiate a temporary workgroup that would meet for a few meetings 1:1 or by email, to really dig into the nuts and bolts of the recruitment plan.

Breakout A.- 10 mins: Recruitment and Outreach through an equity lens

- *a.* Some participants had technical issues accessing the Jam Board. A new link was provided in the chat.
- How will our strategies reach our community far and wide?
- How can we develop strategies that are inclusive?
  - It's been considered to expand outreach by having Radio Ads in Spanish
  - Attending PTO meetings in schools was discussed
  - Outreach at head starts to recruit members
  - Tabling at community fairs with Homes for Good, the Farmers Market and the Whittaker community
  - Looking at our annual CAC demographic report so CAC doesn't miss anyone
  - Any remaining questions should be placed in jamboard

Breakout B. - 10 mins: Designing messaging for the CAC's outreach efforts

- *a*. Nena shared current CAC flyer.
- discussed that flyer can be brought to tabling events or shared online
- QR code on flyer will take user to online CAC application
- Attendee shared concerns that people might feel intimidated by the application process, (i.e., rigorous qualifications.) Need to emphasize that it is open to anyone, especially those who have been marginalized
- Attendee shared that it feels a bit wordy and overwhelming
- Attendee shared that using words like "equity practices" might be a little too high-level
- Attendee also shared that having CHA/CHP language might be confusing to those who have not heard of it
- Attendee asked if Open Card members are eligible Nena will circle back and ask
- Attendee shared that they wished foster parents/guardians of children in out-of-home care who are OHP members would be able to have a voice on the CAC

• Two attendees suggested simplifying the language to be easier to understand (example: "help decide how community investment funds are spent" should be rephrased to "help decide how money is spent for the community")

• Another attendee suggested "we want your support to help make this process easier for others and how we can improve it for those who may access OHP in the future, use lived experience to make healthcare better."

Kayla Watford: If folks want to dig into the planning, there will be a stipend opportunity for OHP members too. I think the meetings will run further than March.
