### Call to Order & Opening Remarks

**Mary Rumbaugh**, called the meeting to order at 9:02am. Introductions commenced.

- Tribal led opioid treatment facility.
- Shower & laundry trailer in clinic parking lot.
- Clinic sees about 200 patients daily.
- Offers wrap around services.

**Dominique Lopez-Stickney** provided the Board with an overview of the North Executive Committee & North Board charters.

- North EC charter highlights:
  - EC charter did not exist, this closely mirrors the Board charter.
  - Roles & responsibilities. Had outdated OHA language.
  - Chair/Vice Chair responsibilities.
  - Membership discussions:
    - Addition of CAC Chair/CAC Co-chairs to EC, Sharif agreed it is doable.
    - Clarification on CAC Chair/Co-Chairs, is it multiple people or one?
    - Term limit for non-Chair/Vice Chair.
  - **Action:** 1) remove s to make clear, only 1 CAC person on EC. 2) Terms for positions to mirror Board.
  - **Motion:** to approve North EC charter with proposed edits.
  - **Action:** North EC charter approved with proposed edits.
- North Board charter highlights:
  - Roles & responsibilities.
  - Operating principles, electronic voting discussion. Unanimous versus quorum
  - Membership: removed members annual performance evaluation.
  - Selection process.
  - References.
  - **Action:** 1) include quorum on e-vote. 2) include term rule, minimum one year on Board.
  - Charters reviewed annually in January.
  - Discussion on staggering of term versus all in January.
  - **Action:** rough draft of updated terms and other suggested edits, bring back to July meeting.

## CAC Report

**Sharif Maddox** provided the Board with a comprehensive update on the previous CAC meeting.

- Sharif/Kendra to continue reaching out for new CAC members and potential Board member.

## Leadership Updates

**Dominique Lopez-Stickney** provided the Board with an update on the following:

- Basic Health Plan
  - Phase 1
    - Effective 7/1/24.
    - Includes current TME population 138-200% FPL.
    - No cost to enrollees.
    - Ages 19-64, eligible immigration status.
  - Phase 2
    - Effective 1/1/25.
    - Adds people with income below 200% FPL with current Marketplace coverage or uninsured.
  - Material for members, what is available to them.
    - **Action:** Dominique to follow up with Mary and Nicholas on Trillium 101.
- Community Capacity Building Funding
  - March 1 – May 31.
  - 65 applications received.
  - Two notification periods to CBOs, July 15<sup>th</sup> & Aug. 1<sup>st</sup>.
  - Awardees will be contracted with us for HRSN.
